### **Abstract and Programme**

One of the main goals of the *Europe 2020 Strategy* is to reduce by 20 million the number of people living in poverty or social exclusion in the EU within the next 10 years. In order to achieve this ambitious target, clear and consistent terms of reference must be agreed upon, especially around the concept of poverty measurement.

Existing indicators, initiatives and good practices in Europe have varied across Europe as a result of Member States developing their own policies in the areas of social inclusion, welfare, pensions, healthcare and long term care. Despite a great deal of comparative policy discussion between different countries, more work needs to be done in order to complete the existing set of common indicators. Combined with ambitious EU social objectives, common indicators facilitate the development of mutual learning processes across Europe, with national governments translating these objectives into national plans which are assessed by the Commission and Member States.

This special International Symposium will bring together stakeholders across Europe to analyse the key parameters shaping existing indicators such as the EU 'at-risk-of-poverty' measure (adopted in 2001 at the Laeken European Council), and a threshold based on 'minimum budget standards'. In this respect, a recent EU study on measuring extreme poverty suggests that an EU measure of poverty combining income poverty and deprivation could provide a useful indicator.

The Symposium will discuss strategies for tackling poverty, especially child poverty, in order to create possible solutions and scenarios for the future. Participants will also have the opportunity to explore how to mainstream poverty reduction into a range of key EU and national policies.

The Centre for Parliamentary Studies welcomes the participation of all key partners, responsible authorities and stakeholders. The Symposium will support the exchange of ideas and encourage delegates to engage in thought-provoking topical debate.
