# Improving Member States' Asylum Systems and Defining Good Practices

Valletta (MT), 11-12 June 2012

#### **Target Group**

The seminar is aimed at public officials, caseworkers and staff in asylum departments and bodies tasked with taking decisions on individual asylum applications. It is also of interest to lawyers, consultants, practitioners, NGOs and the private sector involved in asylum and migration decision-making.

#### Description

The seminar will examine the quality of national asylum systems and will allow participants to reflect on how to assess in a meaningful way the credibility of asylum seekers and the evidence they produce. It will also study examples of best practices in coping with the handling of asylum applications and the alternatives to detention of rejected asylum seekers – an important issue for the Mediterranean countries. The seminar will also reflect on the serious shortcomings of the Dublin Regulation in the national asylum systems, as well as highlighting the flaws in the system itself. The link with the Dublin Regulation will be made in the clarification of the CJEU case law, where articles of the EU Charter of Fundamental Rights (CFR) are central. The presentation on CFR will also make reference to the European Convention of Human Rights and present experiences from the Dutch administrative courts in applying the CFR in asylum cases. Finally, the seminar will look into issues of cooperation between EASO and Member States with regard to improving the quality of the asylum procedures.

#### **Learning Methodology**

This seminar will be based on a mixture of presentations, discussions and workshops. It will stimulate active participation and the sharing of policy practices. Specific cases and experiences will be explored. Background documentation will also be provided in an online/e-Learning set up. Speakers will include officials from the EU institutions, national administrations, ECRE staff and practitioners.

#### Objectives

The seminar aims to show participants the importance of their skills in using specific tools whilst assessing asylum applications, in addition to developing and further improving them. The presentations on the Dublin Regulation and CFR will stimulate them to further observe the potential impact of the two instruments, as well as the implications of the EU Courts' judgments on national courts and practices related to granting protection. The seminar will offer an excellent platform for good practices to be defined, which can thus contribute to making the asylum processes in the EU more efficient by respecting quality standards.
