14.45-16.15 Better research for asylum decisions – a discussion with asylum lawyers

Over the past two years, Asylos has supported lawyers in France and Belgium with very different kinds of research assignments, ranging from fully referenced research notes to helping on short notice to verify particular facts related to an individual claim. 13.00-14.30 Afghanistan: Researching country of origin information in conflict and post-conflict settings

Researching human rights violations or making inquiries on refugee stories poses particular challenges in conflict and post-conflict countries: public authorities who issue documents the asylum seekers needs for their asylum claims are absent or dysfunctional. The media is often state controlled and investigative journalism non-existent. The credibility of sources might be very difficult to judge, and often reports from other NGOs on the situation are incomplete. How do existing networks in the field, like international aid agencies and embassies, operate and how can they be asked for assistance? How can researchers evaluate the quality and reliability of their sources? In 2011, Afghanistan was the top country of origin for asylum seekers in the European Union. The discussion will inform Asylos' thinking on setting up an Afghanistan research unit, which is proposed to operate in cooperation with the Danish Refugee Council in Tajikistan, starting in fall 2012 (contingent on funding).
